

Minutes of the La Cueva Band Booster General Meeting  
February 4, 2015

Present: VP Celina Stoyanof, VP Matt Shover, secretary Vicki Porter, director John Converse, and approximately 30 other members.

Meeting called to order at 7:02 p.m.

1) **Minutes:** A motion to approve the minutes from the December 3, 2014, meeting was made and seconded. Motion to approve minutes carried.

2) **Director's Report:** Mr. Converse reported that except for a student moving out of state, the band will have 100% retention for next year's juniors and seniors. He also reported great interest and enthusiasm for incoming students at 8<sup>th</sup> grade night. The design for next year's marching band show is in progress. Times for the District Music Performance Assessment for both the Symphonic Band and the Wind Ensemble are posted on the band website, bigbadbearband.com. State band contest for Wind Ensemble will be Saturday, April 25<sup>th</sup> with the time yet to be established. In both cases, the public and especially parents are encouraged to attend the performances. Mr. Converse expressed his appreciation to Coach Perea for his cooperation in accommodating Winterguard rehearsals.

3) **Student President Report:** The student officers will be holding a pancake breakfast fundraiser at Applebee's restaurant on Holly Ave. Advance tickets only will be sold for \$10 each with the student office account getting \$4 of the \$10 for each ticket sold.

4) **Fundraising:**

- a) Coffee/tea sales will run Feb 5-13 with delivery at the end of February.
- b) Car wash tickets will be available for sale in March with delivery at the end of March. Of the \$9 per ticket sale price, \$4.50 will go into the student account for each ticket sold.
- c) Sales of Tervis cups are ongoing as long as the inventory lasts.

5) **Nominating Committee:** Jeff Hawkins reported that the nominating committee for the 2015-2016 officer slate has been appointed and includes Vicki Porter as Chairperson, Annette Trujillo, Sally Buster, and Carmen Kavelman. The nominating committee will present a slate at the next general meeting of LC Band Boosters on March 4<sup>th</sup>, 2015. Nominations from the floor will be accepted and elections held at the following general meeting.

6) **Other Business**

- a) We still have a critical need for a treasurer to serve the rest of this year's term.
- b) The executive board is also in the process of recruiting 2 volunteers to represent the La Cueva Boosters at POB meetings. We get to share a share of the POB proceeds based on our participation. Anne Zupfer has previously served as an LCBB POB representative and is now on the POB Executive Board. She will help with the transition for the new La Cueva representatives.
- c) It was suggested that scheduling more performances during the 3-day spring trip be considered in the future.
